2. Rules, Forms and Scope of the Statutory Activity and Implementation of Statutory Objectives

Mission, vision

The mission of the Polish Humanitarian Action is to make the world a better place by alleviating human suffering and promoting humanitarian values.

Polish Humanitarian Action helps people (communities) in emergency situations to obtain their independence as quickly as possible and accept responsibility for their own future; it develops humanitarian attitudes and creates modern aid culture. The guiding principle of the Polish Humanitarian Action is to act effectively with due respect for human dignity.

The Foundation aims to organize and provide humanitarian and development, benevolent and charitable, socially beneficial and educational aid, as well as to counteract social exclusion.

PAH's statutory objectives are implemented by:

- Research and collecting information about the needs of assistance;
- Acquisition, transport and distribution of aid measures;
- Establishing permanent and temporary aid missions;
- Creating and supporting the aid units;
- Conducting the publishing and training activities;

- Organising cultural and educational events and information campaigns;
- Organising public charity collections;
- Organising conferences and seminars;
- Conducting humanitarian and development education;
- Organising rest and leisure for children and adolescents.

PAH activity is based on two pillars: aid and education.

Aid activities are directed to communities that are affected by humanitarian crises (natural disasters, armed conflicts), persecution and poverty, in order to guarantee their right to live in decent conditions and the possibility to develop. We provide special protection to children, women, refugees and repatriates and internally displaced persons.

We address our educational activities to the Polish society in order to bring the global issues of the modern world and international aid standards to its attention. We conduct advocacy activities on behalf of our beneficiaries. We also provide the opportunity to participate in cooperation for the development through conscious volunteering.

The work of PAH is guided by: humanitarianism (openness and respect for people of different races, nationalities, and religions, and sensitivity to human suffering), impartiality (we provide assistance as needed, without distinction of parties to the conflict), neutrality (we do not take a position in religious and political disputes), and independence (our assistance aid activities are independent of the state), and such values as solidarity, justice, respect for human dignity, equality, peace and freedom, as well as tolerance and pluralism.

Assistance in emergency situations included:

- provision of first need means,
- provision of temporary shelter,
- reconstruction of public utility buildings,
- restoration of NGOs' property.

Groups of beneficiaries covered by the aid in emergency situations:

- victims of the earthquake in Haiti individuals, community organizations
- victims of floods in Poland individuals, NGOs, Municipal Authorities

Earthquake in Haiti and the flood in Poland

In 2010, earthquakes, floods, storms, volcanic eruptions, drought and other natural disasters claimed the lives of 260,000 people. This was the largest number of casualties per year since 1976. Only during the earthquake in Haiti more than 200 thousand people died. It was also a difficult year in Poland. As a result of the two waves of floods from April through June and the August flooding in Bogatynia some 266,000 people suffered and 18,000 buildings were damaged.

The cost of establishment of the Permanent Mission in Haiti would be too high (very high prices for renting real estates, cars, etc.), that is why PAH started its cooperation with partner organizations working in Haiti even before the earthquake and experienced in helping in this area. In its initial phase, the aid for Haiti involved the provision of hygiene kits and organizing the activities for children in Care Centers, and then the construction of houses, the conversion of temporary shelters into permanent households as well as the replacement of equipment for the prosthesis-producing workshop.

The aid given to flood victims in Poland involved in the first place: providing food, hygiene kits, tools to liquidate the consequences of the flood, delivering other basic necessities, and then financing the equipment and renovations of public buildings.

Activities performed to the benefit of the victims of emergency situations in Haiti and in Poland are being continued in 2011.

2.1.1.2 Long-term Assistance Program

Long-term Assistance Program included:

• provision of acces to water and decent sanitation,



- provision of acces to food,
- provision of acces to education,
- strengthening of the beneficiary in its quest for independence.

Groups of beneficiaries covered by the long-term program aid:

- communities of South Sudan, Palestinian Autonomy, Afghanistan;
- children in Poland covered by the PAJACYK program;
- refugees, repatriates and foreigners in Poland.

2.1.1.2.1 Providing Access to Water and Decent Sanitary Conditions

"Access to clean water is a basic need of every human being, and thus his Fundamental right" said Kofi Annan, the former UN Secretary General. The Universal Declaration of Human Rights guarantees every person the right to the goods that are essential to life. Such goods include water for personal and household use. Access to water and decent sanitation is also a prerequisite for social development and poverty reduction. It affects the development in other sectors: education, agriculture and public health. PAH has been conducting its support activities in water and sanitation sector since 2000.

In 2010, such assistance was continued in the Palestinian Autonomy and South Sudan.

2.1.1.2.2 Providing Access to Food

Constant access to food is one of the basic human needs. Meanwhile, every sixth person on earth suffers from starvation and a starving child dies every five seconds. Poverty, climate changes that cause droughts and floods, as well as free market rules that are discriminatory to the poorest societies result in a continuously deteriorating situation with access to food. Over the past two years, the world food prices increased by 83%. Direct consequence of the increase can be chronic hunger, which will touch another 750 million people.

According to statistics, Poland held last positions (among the EU member states) when it comes to indicators on the conditions and the quality of life. Many families lived at the edge of poverty, which largely affected children. Every fifth child in Poland (22 percent) lived in poverty. Another 24% of children and young people in Poland are at risk of poverty. There are quite many reasons for that situation; high unemployment rate, lack of resourcefulness of the family, lack of proper education, and pathologies. Poland spends the smallest portion of its resources for social assistance as compared to the entire European Union, and family allowances thresholds have not been raised since 2004. The state runs the government scheme "State Aid for Nutrition"; however, due to the criteria adopted in this scheme, the children of families whose income criterion slightly exceeds the state requirements remain without any assistance. At the same time, municipalities have a problem with the use of their funds and they return about PLN 10 million to the state budget annually.

Malnutrition of children leads to impaired physical and mental development as well as low self-esteem, which has a negative impact on normal participation in social life. Children neglected and suffering from malnutrition are often rejected by their peers and sometimes also by adults.

PAH aims to reduce the number of hungry and malnourished children in Poland and worldwide. We deliver food to victims of armed conflicts and natural disasters. We also create conditions for the development of self-dependent food production in the poorest countries and developing countries. Under the PAJACYK program, we have been financing meals for children in schools and their day-care centres in Poland since 1998.

PAH continued its efforts to secure access to food in South Sudan and under the PAJACYK program in Poland in 2010. In addition, as part of the PAJACYK program, PAH granted the funding of meals for children from families that lost their income sources due to the flooding.





2.1.1.2.3 Providing Access to Education

Everyone has the right to education. Meanwhile, millions of children worldwide do not attend school and millions of adults cannot read and write. For years PAH has been implementing projects aimed at giving an educational chance for children in the poorest countries of the world. This follows from the belief that education is one of the ways of reducing extreme poverty. Under those framework activities, PAH rebuilds and equips schools, distributes school kits; organizes activities on how to learn reading and writing, foreign languages, or computer skills. It also finances the production of educational materials, such as books or movies.

In Afghanistan, approximately 90% of girls and women aged above 15 and 63% of boys and men are illiterate. Although about 4,500 new schools were built over the past 10 years, only about 50% of school age children went to the first class. Circa 7.5 million children still do not attend school.

PAH continued projects to provide access to education in Afghanistan, Palestinian Autonomy and South Sudan in 2010.

2.1.1.2.4. Supporting beneficiaries in their aspiration for self-reliance

All PAH's aid actions include capacity building elements of the beneficiary, aimed at improvement of professional skills, theoretical and practical knowledge needed to cope with difficult life situations.

Such activities accompanied all the above-mentioned aid actions in 2010. Independent projects for building of beneficiary's potential were carried out in Poland in relation to refugees, repatriates and foreigners who came to our country in search of a better life.

In 2010, as part of the PAH Counselling Centre for Refugees and Repatriants (CPUiR), beneficiaries took advantage of skills improvement training courses. They were receiving support under the labour club for people covered with one of the forms of protection in the territory of Poland, and also for repatriants and their families. They received a guidebook "Poland for You" and participated in integration meetings organized by PAH. In 2010, CPUiR maintained Internet portals - www.refugee.pl and www.uchodzcydoszkoly.pl, kept sending e-bulletines, published a newspaper *Refugee.pl* and managed the Refugee Home for 30 people in particularly difficult life situation. The Centre users were receiving support in clarifying the issues of legal and social nature.

PAH carried out actions for refugees, repatriates and foreigners also by changing attitudes in communities hosting foreigners. It organized training courses for staff of the schools receiving refugee children (teachers, headmasters, counseling teachers and school psychologists who worked with children of the refugees).

2.1.2 Education

Educational activities included:

- cooperation with educational institutions the transfer of know-how about the global relationships and needs of the developing countries
- building public awareness of humanitarian and developmental issues towards a sense of responsibility for the world,
- advocacy,
- cooperation in volunteering.

Groups of beneficiaries covered by educational activities:

- children, young people and educational staff of educational institutions,
- students and academics,
- overall society,
- decision-makers,
- volunteers people diversified by age and professionally.

Each of us - regardless of age or wealth - can and should help others. But in order for that help to be effective, we must help wisely, i.e. we need to have knowledge about the needs, apply international aid rules and standards as well as act with respect for the dignity of beneficiaries.

Our objective is to achieve the greatest commitment possible of the Polish society in helping the victims of natural disasters, armed conflicts and poverty. In parallel with the support programs, we conduct educational programs about the phenomena in the contemporary world and pass on knowledge about global relationships and needs of the developing countries. We inform about humanitarian crises. We also teach others to help in a wise and effective way, based on understanding others' needs and cultural conditions, and, above all, with respect for dignity of the other human beings. By using specific programs we not only build the solidarity with the poorest, but also the awareness of the positive force which is capable of changing the world for the better, and which is deeply rooted in our society.

2.1.2.1 Know-how Transfer in Cooperation with Educational Institutions

As part of the cooperation with educational institutions, we conducted national and international projects: "Global School Operates Locally" "Humanitarian School," "Stylishly and Ethically" and such actions as "Well for the South" and "Action - Education".

Projects were addressed to teachers, pupils and students, as they either already have or will have a real impact on the fate of the poorest people in the world in the future. Over 3,000 schools participated in our campaigns, actions and educational programs.

Based on our initiative and with our support, the schools cooperating with us were pursuing activities related to issues of providing access to water and education in the world, poverty, climate changes and trade relations in the world (including the idea of Fair Trade). Students acquired their knowledge on these subjects during topic-based classes that were conducted by teachers trained by us. Also, they implemented activities and student projects, often getting the local communities involved.

The aim of the actions taken was to raise know-how and awareness of the recipients in the field of global interdependences, the situation of the societies in the countries of the Global South and the communities and groups which are targeted by PAH aid programs. International projects have strengthened PAH in its role as a coordinator of educational activities on a European scale and allowed for deepening of the cooperation with partners from other EU member states.

1.1.2.2. Building of Social Awareness - Campaign and Advocacy

In 2010, PAH celebrated such events as: the World Water Day, the World Food Day, the World Poverty Day, the World Refugee Day, the International Day of Human Rights, and the World Day of Toilets for the first time in 2010. Together with the Foreign Group, PAH initiated and led the intersectorial process of global education, which was attended by the representatives of the Polish Ministry of Education and the Ministry of Foreign Affairs. This process resulted in the signing of the agreement in May 2011 to support the development of global education in Poland.

At the same time, these actions were accompanied by a constant engagement of the Polish society in both immediate and systematic actions for residents of the countries poorer than Poland. Those activities also aimed at mobilizing the people responsible to make the necessary legal amendments on issues, such as regulatating the rules for providing Polish foreign aid and regulations on public collections as well as introducing significant changes into the existing legal regulations referring to the repatriates (in December 2010, Poland's lower parliament house, the Sejm, held 1st reading of the bill).

In 2010, under the auspices of PAJACYK – the World without Hunger, we initiated a new campaign which aims to draw the attention to the problem of hunger and malnutrition among children in Poland and abroad. The campaign started as a result of a decision to extend the children feeding program conducted in Poland (Pajacyk) to African countries.
